Based on and inspired by the article published in the investigative media BIRN (Reporter.al) "Refinery, not perfumery", regarding the rise of the voice of residents around the former Metalurgic against pollution, on 20 February 2018, AHC verified the field of air pollution, as a result of heavy oil wind and water pollution in irrigation canals, as a consequence of the emergence of hydrocarbon residues. THE DEATH OF CITIZEN ENEA FTOI REQUIRES A COMPLETE AND THOROUGHLY **INVESTIGATION**



AHC on May 17, 2018 was informed by the family members of the citizen Enea Ftoi, arrested from the Korca Police Forces, that he was dead on the police custody and was transported in the Regional Hospital of Korca. AHC expresses his condolences of the victim's family members, and suggests to the relevant criminal prosecution authorities to investigate the case in a comprehensive, objective and complete manner, more so than the death of the victim occurred in the premises of the police station after 3 days of his arrest. FREEDOM OF PEACEFUL ASSEMBLY AND PARTICIPATION IN THEM IS **GUARANTEED**

According to information from the media and statements by the police, a total of 23 persons were detained and 13 police officers were injured during the Kukës protest. The criminal case has been initiated and justice bodies are the ones to decide on everyone's responsibility or lack thereof. During monitoring missions that AHC has conducted based on complaints of citizens about violations of their rights, it has found lack of information and consultation on issues and causes of public interest, particularly regarding the situation of the environment and its condition, which runs against article 56 of the Constitution ... APPLAUD FOR OPENING **OF NEGOTIATIONS**

AHC is also of the opinion that, for the government and all political forces, this important and historic decision should be a test of reflection for doing a balance sheet of what has been done and what needs to be done. AHC suggests that at the center of this analysis should be constructive criteria, respect for the principle of the checks and balances of powers, increased responsibilities, transparency and accountability by public bodies toward citizens, the avoidance of extreme inequality and the fight against discrimination, the avoidance of hate speech and the tense political environment. ... The vetting process is still accompanied by a marked level of lack of transparency by supporting bodies for the broad public, in spite of efforts of the Albanian Helsinki Committee, which turned into legal battles, some of which were won.



"VETTING UNDER THE OBSERVATION OF THE ALBANIAN HELSINKI COMMITTEE".

Pursuant to monitorings realized in the context of the initiative "Increasing transparency, inclusivity and responsibility in the vetting process," supported financially by the Open Society Foundation for Albania, AHC has published a report on the main findings. Due to the importance and volume of the vetting process, which envisages the transitory re-evaluation of about 800 individuals, AHC is aware that this process is complex and difficult. Nevertheless, AHC deems that this high volume of work requires an activity at a higher and more dynamic pace from independent constitutional institutions of vetting, without affecting the quality of the vetting process... DISCRIMINATION

THE COURT FINDS THE DISCRIMINATION OF THE CHILD WITH SERIOUS ACCURACY IN HEARING AND ORDER THE CORRECTION OF HEALTH CONSEQUENCES

AHC addressed the case to the Administrative Court requesting the finding of discrimination of juvenile GL in the form of "Denial of a Reasonable Adjustment", correcting the consequences by performing administrative actions for the provision and placement of the Coclear Implant to the minor and to compensate for the damage caused by the non-setting of the Coclear implant device. On dt. 10.04.2018, the Tirana First Instance Administrative Court announced the decision that it acknowledged that because of the inactivity of the abovementioned health institutions there has been discrimination of the juvenile, GL and has ordered the installation of the Coclear implant device to the minor and the reimbursement of the calculated damage to the extent of 6 838 590 lekë ... ANOTHER STORY OF SUCCESS ...

Thanks to the media investigations, AHC monitored and provided legal assistance to the issue of discrimination due to the economic and social situation of citizens residing near the former Torovica Camp, the Administrative Unit Balldre, the Municipality of Lezha . After identifying the disturbing issues faced by 15 families living in the former camp's building, AHC secured the consent of three of the residents to represent their case legally. These residents lived in very difficult and miserable conditions in the former building that used to serve as a prison camp in Torovica. The Commissioner noted the discrimination of residents due to their economic and social situation, from the Lezha Municipality Structures. Also, the Commissioner ordered immediate measures taken by Lezha Municipality for providing drinking water, urban waste containers, for finding alternative housing solutions and improving road infrastructure for these residents. VIOLENT EXTREMISM, THE GREAT ACTUAL CHALLENGE

On April 6, AHC organized a Steering Committee Meeting with the winning organizations of the project "Civil Society Against Violent Extremism". At this meeting, representatives of grants supported by the project presented the activities of their projects implemented so far.Also,cooperation opportunities between organizations were established and joint synergies were established for the implementation of project activities, as well as the establishment of the Local Public Safety Council (LPSC) by the representative of GUS Albania, Derand Krasniqi. The meeting was welcomed by AHC's Executive Director, Erida Skëndaj and also by Mr. Agron Sojati, National Coordinator against Violent Extremism... See: Artikull





In order to increase the capacity of civil society to promote tolerance and cooperation among the various actors of the society, and to address this phenomenon locally, on 20 April 2018, AHC organized a training where topics related to national and international legal standards against violent extremism, international strategies for the prevention of violent extremism, hate speech and its implications with violent extremism, best practices of co-operation among partners in dealing with violent extremism issues, the role civil society in the fight against this phenomenon, etc. About the activity of partner organizations : FB'Page

WE ARE LATE ON ELECTORAL REFORM

The Albanian Helsinki Committee (AHC) expresses its concern about the fact that although today, April 13, 2018, the 6-month mandate of the Special Parliamentary Commission on Electoral Reform ends, there is no information on whether consensus has been reached on any important issue that has been addressed or whether work has begun on writing the draft-amendments to this Code. AHC suggests that the pace of the Commission for Electoral Reform be accelerated and the results be effective. This would create the conditions for meetings to realize inclusivity to focus on the main issues that also are of public interest especially for voters For more: <u>Artikull</u>

STUDENTS SHOULD BE ENCOURAGED TO DENOUNCE CORRUPTION IN THE HIGHER EDUCATION SYSTEM

In forums organized by AHC in recent months, with Public students in Universities in Shkodër, Durrës, Elbasan, Vlorë, the Science Institute in Tirana. etc., there have been numerous and very disturbing discussions about the phenomenon of corruption, particularly in terms of ensuring fictive grades. During discussions, it resulted that this phenomenon was not sporadic, but practiced and spread for a long time. Students also raised claims about other corruptive forms, namely inclusion in exams of students who have exhausted the maximal number of absences for registration for exams, as well as cases of abuse by the secretariat and administrative staff to change grades, or obtain documents from the Faculty. Students also shared cases of unethical behavior by professors, such as the mandatory purchase of textbooks and materials prepared by the professors "ghost" themselves, professors who never came to class for the majority of the academic year. implementation. Until the exercise of the right to a legislative initiative aimed at adapting this legal framework to the best models of other countries and to the socio-economic conditions of our country, AHC has suggested looking at the possibility of revising this legal framework.
