## Legal clinic International day of HUMAN RIGHTS

On the International Day of Human Rights, we commemorate the 70th anniversary of the adoption by the United Nations General Assembly of the Universal Declaration of Human Rights. The statement represents the first global effort to articulate the protection of those rights many people believed were fundamental rights to all human beings.

Today, non-respect of citizens' rights continues to be a widespread problem in all parts of the globe, including our country. We appreciate that youth participation is a value to be promoted and constitutes one of the guiding principles of the Declaration. #### ADMINISTRATIVE COURT OF THE FIRST LEVEL OF TIRANA APPROVED THE DECISION OF THE COMMISSIONER FOR PROTECTION FROM DISCRIMINATION



On 19 November 2018. the Tirana First Instance Administrative Court stated positively by leaving the Commissioner's Decision on Protection from Discrimination in force. Through this decision-making, initiated by a complaint lodged by the Albanian Committee, it is noted Helsinki the discrimination of prisoners working in the prison system, to whom the same practice as regards the recognition of work and the related remuneration is not applied. This issue is represented in the framework of the initiative "Improving the human rights situation in Albania by strengthening the rule of law -Legal Clinic XII, which is funded financially by Civil Rights Defenders. #### CHANGES IN THE ELECTION CODE ON THE BASIS OF THE OSCE / ODIHR RECOMMENDATIONS

The Albanian Helsinki Committee (AHC) expresses its concern that the Assembly's calendar for the period 3 December - 21 December 2018 did not foresee anything to discuss or approve changes to the Electoral Code on the basis of OSCE / ODIHR recommendations.

It seems that the statements made that changes to the Electoral Code would be approved within December of this year will not be realized.

AH in light of the negative experience of the 2017 election, when no change was made in the Electoral Code and the difficulties that were created in this case, calls on the majority and the opposition to maximally assess this issue with dialogue, transparency and consensus.

Silence and indifference creates a healthy ground for corruption and abuse of office, which in one way or another directly affect everyone's life. You can see how it works or applies for a new job as soon as a corruption practice is practiced. Whistleblower is a civic reaction through which refusal to comply with corruptive actions. The law guarantees a rapid and credible administrative investigation procedure, based on the principle of maintaining the confidentiality of information and state secrecy. Civil society organizations through this public statement want to express their support for the student's demand for increasing the education budget in Albania at 5% of gross domestic product (GDP).

Albania invests only 3.3% of GDP on education, far from international and regional standards. This low investment rate undermines the rights of children and young people to provide free, quality and inclusive public education for all. In revenue-generating countries like Albania, a \$ 1-invested investment in education would generate more than \$ 5 in revenue per country per year. The Albanian Helsinki Committee (AHC) and the Institute of Political Studies (ISP) with the support of the Open Society Foundation for Albania during 2018 conducted monitoring of the process of vetting judges and prosecutors and public and political discourse on judicial reform. The main findings of the relevant reports for periods until June 2018 (vettingu) and August 2018 (discourse) indicate that:

• Justice reform continues to be the main institutional priority in Albania, but progress towards its quality performance, continues to be disproportionate to public expectations and institutional needs.

- The new legal framework of justice is not yet being implemented.
- The current balance of vetting process is positive, but still insufficient to achieve results of reform and reflection on the new system....... For more information click on the link: <u>ARTICLE</u>

## ON THE SITUATION OF RESPECTING HUMAN RIGHTS AND FREEDOMS IN ALBANIA DURING 2018

During 2018, the Albanian Helsinki Committee (AHC) has focused its activities on important areas such as the implementation of justice reform, access to justice for vulnerable groups, respect for human rights in penitentiary institutions, police commissariats, hospitals psychiatric, border crossing points and asylum seekers centers, prevention and fight against violent extremism and discrimination, promotion of free media, transparency and good governance of institutions, environmental protection, etc.

AHC has conducted frequent monitoring, has undertaken awareness raising campaigns and legal education, has reacted publicly to cases of flagrant violations, communicated with state institutions with requests for information and addressed concrete recommendations, provided free legal services to vulnerable groups, such as and has represented issues of public interest in the Constitutional Court and the European Court of Human Rights. The process of vetting judges and prosecutors, although accompanied by some delays, has raised high interest in the public. Citizens have followed a considerable number of complaints to the vetting bodies, but in no case does it appear that they have requested the status of a justice collaborator. AHC has been recognized and followed the protests by residents of the Astir area of the city of Tirana, whose homes have been demolished as a result of the implementation of the New Ring Road Project. A representative of the Albanian Helsinki Committee held a meeting yesterday, with some of the residents of this area protesting their rights.

Such performances belonging to the distant past have nothing in common with the good neighborly relations between the Albanian people and the Greek people, as well as European standards, to live in peace, democracy and stability. ### ALBANIAN AUTHORITIES ORDERED TO OFFER PURE WATER FOR COLOURED PERSONS AFTER THE CASE OF DISCRIMINATION

Tirana, Budapest December 10, 2018: A Roma community in Fushë-Kruja, Albania, has won a case before the Commissioner for Protection from Discrimination after opposing the local municipality for refusing to provide clean drinking water and sanitation. The commissioner found that the Municipality of Kruja had discriminated against Roma families living in the Kastriot neighbourhood based on their ethnicity and socio-economic status and ordered the municipality to take immediate measures to correct the situation or face a fine. The case was sent to the Commissioner of the Albanian Helsinki Committee (AHC), with the support of the European Roma Rights Center (ERRC), which provided evidence on the ethnic division of access to water in Albania.:<u>ARTICLE</u>
